

## Uniform Requirements

- A high standard of personal presentation is expected of students at all times and care should be taken to keep uniforms in good condition. If a uniform is soiled or damaged and requires repair or cleaning, then an exemption card is required.
- All students must ensure their summer and winter uniforms are worn at knee length.
- Blazers are to be worn to and from school each day, including on buses travelling to or from the College, unless the outside temperature is over 23 degrees.
- The College boater is a discretionary part of the College uniform for students in Years 5 - 10. It remains a compulsory part of the uniform for students at the College up to Year 4 and is to be worn to and from the College.
- Years 1 – 6 students are to wear their full tracksuit to school on PE lesson days.
- Secondary students are permitted to wear their full sports uniform to school ONLY if they have a double lesson requiring it. For single lessons, students must wear their formal uniform to school and change into their sports uniform. If single lessons are in Period 3 or 4, students may wear full sport uniform home. This applies for the entire school year. Sports shoes that provide appropriate ankle support should be worn e.g.: casual street footwear is not appropriate. Formal uniform to be worn at all other times.
- Students involved in after school training or sports competitions representing the College may wear full sports uniform home. This applies for the entire school year. Formal uniform to be worn at all other times.
- College bike shorts/leggings are not to be worn to and from the College. They are only to be worn in PE and/or Dance lessons. Leggings with brand names are not permitted.
- College trousers form part of the formal uniform and should be worn with the College shirt and tie.
- Where extra warmth is needed, navy school scarves may be worn (except in the instance of safety reasons in lessons) or the College woollen vest with the winter uniform.
- In accordance with the College Sun Protection Guidelines, students are encouraged to wear the College bucket hat or College boater when outside from the beginning of September to the end of April. The College cap does not offer enough protection and is not recommended for general use. Students without a sun-safe hat or clothing are encouraged to remain in the shade.
- The College cap will be permitted for use for approved sporting activities where the use of a sun-safe hat is impractical.
- Hair over collar length must be fully tied back with a regulation navy or white ribbon or headband. Any clips or combs used should be in neutral colours. Extreme hairstyles are unacceptable, including, undercuts or shaved, obviously dyed hair, hairstyles that incorporate two starkly contrasting shades such as bleached blonde and dark brown, hair dyed black and hair bleached very blonde. If a student's hair colour or style is unacceptable she will be required to alter it within a set period of time.
- Small plain silver or gold sleepers or studs, including small pearls and clear diamante, may be worn. Two earrings maximum per ear. No dangly or drop earrings to be worn.
- It is expected that a Secondary student wishing to pierce their nose, does so 6 weeks prior to commencing the school year as only a clear small retainer will be permitted in the nose whilst at school.
- A watch is able to be worn at school but rings, anklets and bracelets are not permitted to be worn at any time due to occupational health and safety reasons.
- Students are not to wear coloured nail polish, acrylic nails, excessive eyelash extensions, makeup or fake tanning products with their school uniform.

As a high standard of personal presentation is expected as outlined in the Uniform Requirements, students that do not adhere to this expectation and do not wear their uniform appropriately etc will be issued with an infringement on the date this is observed and noted in SEQTA by a member of College staff.

Below is a table outlining the consequences of poor personal presentation.

Three (3) uniform infringements recorded	Conversation held with student and clan teacher regarding meeting College Uniform expectations.	Parent/Carer notification via SEQTA electronic letter.
Agreed outcomes with Clan teacher not met.	Conversation held with student and Head of House regarding meeting College Uniform expectations.	Parent/Carer contact with the relevant Head of House. Agreed outcomes documented with the student on SEQTA and electronic correspondence sent to Parent/Carer.
Agreed outcomes with Head of House not met.	Conversation held with student and Deputy Principal regarding meeting College Uniform expectations.	Parent/Carer contact with the Deputy Principal. Agreed outcomes documented with the student on SEQTA and electronic correspondence sent to Parent/Carer.
